# Trends in ODA to Agriculture (and rural development) Facts and figures from OCDE sources

- Low share of total ODA (6 to 7%)
- Decline by half between beginning of the 80s and the mid 90s, both for multilateral (first), then bilateral
- Then quasi-stagnation after 2010, corresponding to a small rise of the share in total ODA

1973-2013, 5-year moving average ODA commitments, constant 2013 prices






Chart 5. Bilateral and imputed multilateral ODA to ARD


2004-13, USD billion, constant 2013 prices

## Trends in ODA to Agriculture (and rural development) Reasons and hypotheses

- For the decline: resurgence of an urban bias in spite of the priority given to the reduction by half of the population undernourished in the MDGs, and of the goal of food security
- For the reversal: several factors,
  - food crises
  - WDR 2007 on agriculture
  - new concern of « value chains », productive capacities, etc?
- For the last phase: a new matter of concern? (agriculture never quoted in important reports on development finance)
- Exception: chapter A. de J and Sadoulet in *Financing Development Sustainability. Addressing Vulnerabilities*



## ODA to agriculture or development finance for agricultural development?

- Heterogenous content of ODA to agriculture, possibly associated either to agro-industry or to rural development (graphs): no clear statistics on the share of ODA benefitting to rural areas
- Diversity of instruments to support agricultural production :
   is ODA (presently 2/3 in grants) always needed to agriculture ?
- ODA not necessarily needed if agricultural activities are competitive
- But ODA needed to make these activities competitive by irrigation, research, agricultural training, numeric connection, access to energy ...
- ... and most important, to lower the risks inherent of agricultural activities in vulnerable environment(Cf P.Jacquet in OCDE)
- Aid to adaptation will be to a large extent an aid for agriculture

2012-13, bilateral and multilateral ODA commitments, constant 2013 prices





Chart 2. Regional breakdown of aid to ARD 2012-13, bilateral and multilateral ODA commitments, constant 2013 prices
