#### **WORKING WITH FRAGILE STATES**

The Practitioners Network (host), Cordaid and FERDI in collaboration with the European Commission (DEVCO B7) will organise on June 15<sup>th</sup>, 2016 a high-level panel on the theme "Working with fragile states" as part of the European Development Days 2016 – Europe's leading forum on development and international cooperation.

Bringing together high-level representative from third countries, member states agencies, the European Commission, civil society organisations and youth representative, the panel aims at fostering a thought-provoking debate on the needs encountered in a context of fragility and draw recommendations for better effectiveness.

## WORKING TOGETHER IN FRAGILE STATES FOR BETTER EFFECTIVENESS

A reality check and ways forward from a multi-stakeholder perspective

June 15<sup>th</sup>, 2016 | 18:00 – 19:30 | Venue: Tour & Taxis, Brussels

### **Event description**

Fragile states are at the centre of the international community's attention. However, international frameworks and guidelines on improving coordination and effectiveness on the ground show limited results. The urgency and the scale of the needs of these countries require a concerted action by all development actors, as well as in all dimensions of development. In this light, it is essential to design well thought-out yet adaptable actions based on field experience to promote sustainable development in a context of growing and resurgent insecurity.

Discussions will focus on the shared observation that despite multiple commitments and strategic orientations, the response to state fragility remains to be achieved. The panel will aim at identifying modalities for closer cooperation, synergies between areas of action and characteristics that makes resilience and transition possible to ease a long-term development process.

## Expected outcomes

- Assess the cost of doing nothing in fragile states
- Identify key vectors to successfully implement and apply international commitments in fragile environments
- Determine the role of the European Union and its partners to address fragility

## Organisers

The Practitioners' Network (PN) is an open platform for exchange, coordination and harmonization between European organisations with a public mandate in the field of European Development Cooperation. Set up in February 2007, the PN is currently composed of 13 member state agencies<sup>1</sup> and the European Commission as an observer. The aim of the Practitioners' Network is to contribute to the coherence within the EU donor community and, at the same time, benefit from the wide diversity of organizations so as to have an integrated, pluralistic and innovative approach to European

Development Cooperation, delivered through the highest levels of efficiency. The Practitioners' network is the lead organizer of the high-level panel.

The Foundation for studies and research on international development (*FERDI*) is a French think-tank that aims at facilitating the understanding of mechanics and logics of economic development throughout the world. They work on various issues and hold a working group on "Peace, Security and Development" that gathers international high-level experts.

**Cordaid** is a Dutch non-profit organization specialized in aid emergency and health. They work on sustainable development and supporting economic opportunities in post-conflict countries. **World Vision** a Christian humanitarian organization dedicated to working with children, families, and their communities worldwide has also joined the preparation of the session.

## **Topic**

The organisers of this high-level panel all have an acute awareness that fragility is the most challenging issue as regards development cooperation. The need for more effective donor coordination in situations of crisis and fragility is all the more urgent, given that the international community is faced with new security and development threats in Sahel, Central Africa and the Middle East. This common challenge is an opportunity to create a more integrated and effective European response to contexts of crisis and fragility by translating agreed general principles of aid coordination in operational solutions adapted to the local context.

Contexts of crisis and fragility lead to contradictory obligations: to act fast while perceiving and understanding acutely each specific context; to strengthen actors' capacities over the long term while showing quick results. Fragility implies great capacity needs, which calls for greater coordination and better knowledge sharing.

To reach these objectives, the development community and beneficiary countries need to conceive new modes of acting founded on complementarity and identify each actor's specific function and added value for better effectiveness.

#### Session details

In line with the traditional approach of high-level panel debates, each panelist has an equal opportunity to share his experience and put forward his views independently from his function/title. Such dynamic is seen as one of the main asset of a genuine multi-stakeholder dialogue, whereas the added value of each speaker is at the core of a lively discussion.

The total duration of the panel will be of 1 h 30 min.

Each panelist will be asked to answer one common question at the beginning the session, one personalized question throughout the course of the debate, as well as a second common question at the end of the discussion.

In order to keep a **lively pace to the debate** and allow for **interaction with the public audience**, panelist are kindly asked to limit their respective interventions to 3mn for both common questions and 4mn for the personalized question).

The session would be organized as follows:

- Introduction 5 min
- Debate 65 min (including one 2 min videos)
- Questions & Answers with the audience 15 min
- Closing arguments 5 min
